# 無煙公共交通工具

## Smoke-free Public Transport Carriers

- 根據《吸煙(公眾衛生)條例》(第371章)第4條規定，任何人不得在公共交通工具內作出吸煙行為(即吸用或攜帶(a)燃着的香煙、雪茄或煙斗；或(b)已啟動的另類吸煙產品)。違者定額罰款\$3,000。
- 無論在有否載客的的士、小巴和巴士，在車廂內都不可吸煙，在渡輪上(包括露天甲板)吸煙亦屬違法。
- 一旦被檢控，違例吸煙者必須和控煙酒督察合作並提供所需資料，否則會有更嚴重的刑罰。



公共交通工具包括專營公共巴士、公共小巴、的士、港鐵列車/車輛、電車、山頂纜車、渡輪、或為提供旅遊、國際客運、酒店、學生、僱員、住客等服務而根據客運營業證經營的非專營巴士。任何公共交通工具的司機、指導員、稽查、收票員或管理人等都已獲授權執行有關禁煙措施。



- As stipulated under section 4 of the Smoking (Public Health) Ordinance (Cap.371), no person may do a smoking act (i.e. smoking or carrying (a) a lighted cigarette, cigar or pipe; or (b) an activated alternative smoking product) in a public transport carrier, or else will be liable to a fixed penalty of HK\$3,000.
- Smoking is prohibited in taxis, minibuses and buses even if there are no passengers, as well as on the open-air decks of ferries.
- When approached by Tobacco and Alcohol Control Inspectors, you should cooperate with them and provide the necessary information, or you may face serious legal consequences.



Public transport carriers include any public bus operated under a franchise, public light bus, taxi, Mass Transit Railway train/vehicle, tramway car, peak tramway car, ferry vessel or non-franchised bus operated under a passenger service licence for the purposes of a tour service; an international passenger service; a hotel service; a student service; an employees' service; or a residents' service. The driver, conductor, inspector, ticket collector, or managers of any public transport carrier are empowered in enforcing tobacco control measures.
